Should these charges be declined, this non-maintainable items will be eliminated from the agreement and price adjusted accordingly.

CHARGES:

CHANIN MECHANICAL, LC. may annually adjust any charges for ongoing maintenance or service based on prevailing labor and material costs. Payment of invoices are due upon receipt of invoice or within twenty (20) days of invoice date. Invoices unpaid for thirty (30) days shall be subject to a delinquency charge. If litigation is required to collect unpaid invoices, customer agrees to pay reasonable legal fees and costs.

GENERAL PROVISIONS:

The only parties to this contract are customer and CHANIN MECHANICAL, LC. The services to be preformed under this agreement are not a guarantee against obsolescence or normal wear. Nor shall inspections be constructed as an approval or guarantee of the condition of the equipment. The warranties and obligations set forth herein are in lieu of all other warranties and liabilities expressed or implied in law or in fact including the implied warranties of merchantability and fitness for particular use.

This contract shall be voided if the included equipment, in dealer's judgment, has been subject to misuse, negligence, accident, fire, lighting, windstorm, or vandalism, or if the equipment has been tampered with or altered in any way or operated contrary to the manufacturer's operations.

For any consequential damages of any nature whatsoever, including damages arising because of or resulting from a failure of a component part of the included equipment, or the inspection, maintenance or repair of said equipment.

For system design or performance in maintaining design conditions except through failures or equipment specifically covered herein.

For failure to discover conditions necessitating repairs or replacement.

This contract does not cover electrical service, duct work and insulation, recording instruments, gages or thermometers, water supply and drains, air volume adjustment, plumbing, piping or work required by government and other codes and regulations nor any services performed beyond those specifically enumerated herein.
